

**GENERAL COMPETITION REGULATIONS**  
**as part of the Academic Community Sports Tournament**

1. The organizer of the Tournament hereinafter referred to as the "Tournament" is the Medical University of Białystok, hereinafter referred to as "MUB"
2. The partners of the event are: Białystok University of Technology (PB), University of Białystok (UwB), MUB's Academic Sport Association, and MUB Student Government.
3. Joining the tournament is tantamount to accepting the provisions of these regulations.
4. The tournament is intended for employees, students and doctoral students of the Medical University of Białystok, Białystok University of Technology and the University of Białystok, as well as guests invited to the teams.
5. In the team composition, the number of professional players or those playing in student sports sections may not exceed 2 people, and the number of guests may not exceed 1 person.
6. The tournament may be attended by persons over 18 years of age, whose health condition allows them to participate in the Tournament, hereinafter referred to as "players" or "participants", who will form a team in accordance with the rules set out in these regulations.
7. The tournament will be held on November 14-16, 2022 at the Academic Sports Center at ul. Wiejska 41 in Białystok. The detailed schedule of the Tournament and the regulations of individual competitions will be established after the registration of the teams is completed and will be posted on the MUB website [www.umb.edu.pl](http://www.umb.edu.pl).
8. The tournament will be held in 3 disciplines: futsal, basketball and volleyball.
9. Team registration lasts until November 7, 2022 or until there are no places available. The order of applications is decisive for qualifying for the Tournament. Registration takes place electronically via the form available on the MUB website at the link [https://www.umb.edu.pl/akademick\\_turniej\\_sportowy](https://www.umb.edu.pl/akademick_turniej_sportowy). The captain makes the registration on behalf of the team.
10. The competition is conducted by judges appointed by the Organizer of the competition, who is responsible for the objective conduct of the competition. The powers of the referee and the exercise of the law assigned to him by the Rules of the Game begin when he enters the venue where the competition will take place.
11. Violations committed during a temporary interruption in play and when the ball is out of play are also subject to judges' decisions. The substitute player is also under the referee's jurisdiction.
12. During the match, only the team captain has the right to refer to the referee in a polite and tactful manner, not with regard to his decision.
13. For unsportsmanlike conduct, such as profanity or violent play, the player may be given a suspension.
14. Futsal teams play in teams of five, four players in the field + goalkeeper. The reported team, along with the reserve players, may consist of 5 to 8 people.
15. Basketball teams play in teams of five. The reported team, along with the reserve players, can be from 5 to 7 people.
16. Volleyball teams play in teams of six. The reported team, along with the reserve players, can be from 6 to 8 people. Women are welcome in the team.
17. Each competitor taking part in the Tournament must have a document confirming the identity of the competitor.

18. Each entered competitor confirms in writing that there are no health contraindications for participation in the Tournament and has read the general regulations of the Tournament and detailed regulations of individual competitions in which he takes part and agrees to the processing of personal data in connection with the organization of the tournament. The declaration is attached as Attachment1 to the Regulations.
19. The participants will provide sports clothes and shoes on their own.
20. The number of teams in the Tournament is set:
  - a. futsal up to 12
  - b. basketball to 8
  - c. volleyball up to 16.
21. The following division of the number of teams is established between the Medical University of Bialystok, Bialystok University of Technology and the University of Bialystok:
  - a. Futsal - 3 teams from MUB, 3 teams from PB, 3 teams from UWB, the next 3 teams according to the order of applications
  - b. Basketball - 2 teams from MUB, 2 teams from PB, 2 teams from UWB, next 2 teams according to the order of applications
  - c. Volleyball - 4 teams from MUB, 4 teams from PB, 4 teams from UWB, the next 4 teams according to the order of applications.

The given division was established in order to have an equal chance for each university to submit a proportional number of teams to the Tournament.
22. If a given university does not field the minimum number of teams specified in point 21, these places will be taken over by teams from other universities.
23. It is allowed to form teams consisting of employees and students from different universities, but it is the majority of players from the same university that ultimately decides about the allocation to the MUB, PB or UWB, respectively.
24. It is allowed to resign from holding games in a given discipline in case of notifying a small number of teams.
25. It is allowed, in exceptional circumstances, to change the number of teams or participants in individual competitions, change the detailed rules of the competition and the schedule of the competition.
26. The order of correctly completed applications decides about qualification for participation in the Tournament.
27. A competitor in team competitions in a given discipline may only appear in one team.
28. The organizer will provide the participants with accident insurance.
29. Before the start of the games, each team will deliver the signed declarations referred to in point 18 of the Regulations.
30. There are the following prizes in each of the disciplines:
  - a. 1st place: Team Cup
  - b. 2nd place: Team Cup
  - c. 3rd place: Team Cup.

The winning teams will receive medals.
31. The Tournament Regulations and the application, along with up-to-date information on the tournament, will be available on the organizer's website [www.umb.edu.pl](http://www.umb.edu.pl).
32. All Tournament Participants are required to behave in a manner that does not endanger the safety of other people, in particular to comply with health and safety and fire regulations and the provisions of these Regulations.

33. Participants and all persons present in the tournament are obliged to follow the Organizer's instructions.
34. It is forbidden to bring weapons, ammunition or other dangerous items, explosives, pyrotechnic products, fire-hazardous materials, alcoholic beverages, intoxicants, psychotropic substances and other similar substances.
35. The following persons are not allowed to enter the tournament area:
  - a. under the influence of alcohol, drugs, intoxicants, psychotropic or other substances having a similar effect,
  - b. behaving aggressively, provocatively or in any other way posing a threat to the safety of the Tournament Participants or public order,In addition, it is prohibited to:
  - a. entering or passing through facilities, areas and devices not intended for general access,
  - b. enter service premises, pass through places not intended for the public, fenced off or otherwise protected against access by unauthorized persons.
36. It is forbidden to conduct any commercial, profit-making, promotional, advertising or political agitation activities in the area of the tournament without the Organizer's permission.
37. The organizer reserves the right to remove any tournament participant who violates the provisions of the Regulations, the rules of public safety, the rules of personal culture or disturbs other people in the reception of the tournament.
38. It is forbidden for the Participants to take any actions that may infringe the rights of third parties or the organizer.
39. In the case of noticing a fire or other event posing a threat to the safety of life, health or property, Participants and people currently in the tournament area should:
  - a) Notify the security services immediately,
  - b) Avoid panic, follow the Organizer's instructions,
  - c) Leave the tournament grounds calmly, following the evacuation signs and fire instructions.
  - d) If necessary, notify the competent service: Fire Brigade, Police, Ambulance Service (emergency number 112).
40. By entering the Tournament Area, you accept the provisions of these Regulations and the Regulations of the Academic Sports Center.
41. The organizer provides only ad hoc assistance in the event of injuries caused during the game, but is not legally responsible for the participation of sick people and the resulting accidents and the consequences of accidents during the game of each player.
42. The organizer is not responsible for the material losses of the participants incurred during the tournament, including the items left by the participants.
43. Any disputes arising during the tournament will be settled by the Organizer.
44. The Organizer reserves the right to use worldwide, free of charge, any photos, film materials, interviews and audio recordings depicting the Tournament.

## INFORMATION ON THE PROCESSING OF PERSONAL DATA OF PARTICIPANTS OF THE TOURNAMENT

Each tournament participant acknowledges that:

1. The administrator of personal data is the Medical University of Białystok, with its seat at Kilińskiego 1, 15-089 Białystok, represented by the Rector
2. Contact to the Data Protection Officer at the Medical University of Białystok, e-mail address: iod@umb.edu.pl
3. My personal data will be processed in order to conduct the Tournament and for promotional purposes related to the Tournament on the basis of my consent (Article 6 (1) (a) and Article 9 (2) (a) of the GDPR)
4. The recipients of personal data may be external entities providing services related to the ongoing activities of the University, providing and supporting the University's IT systems.
5. My personal data will be stored until December 31, 2022
6. I have the right to access my data, the right to rectify it, the right to limit processing, the right to delete data, the right to transfer data, the right to withdraw my consent at any time on the terms set out in the GDPR. I can exercise my rights by contacting the Data Protection Officer at the following e-mail address: iod@umb.edu.pl
7. I have the right to lodge a complaint with the President of the Personal Data Protection Office, ul. Stawki 2, 00-193 Warsaw, when it is justified that my personal data is processed by the administrator contrary to the GDPR.
8. Providing data in the application form is voluntary, but without providing this data, participation in the Tournament will be impossible.
9. Based on the provided personal data, no automated decisions will be made, including profiling.
10. Participation in the tournament is associated with the recording and dissemination of the image and voice of the participants by: free of charge recording, photographing, filming or making any other record of his image or voice in connection with the tournament, transmitting, disseminating or showing his image in connection with the promotion of the tournament, in particular, posting an entry on the website, in social media, in publications, in the media.
11. The Participant is not entitled to any claims against the Organizer in this respect.
12. I will provide the above information on the processing of personal data to all team members whose data I provide in the application for the Tournament.
