

GENERAL RULES OF THE GAMES

as part of the Charity Football Tournament

General provisions

§1

1. The organizer of the football tournament, hereinafter referred to as the "Tournament", is the Medical University of Białystok, hereinafter referred to as "MUB".
2. The partners of the event are the City of Białystok and Jagiellonia Białystok.
3. Joining the tournament is tantamount to accepting the provisions of these regulations.

Conditions of participation

§2

1. The tournament may be attended by persons over 18 years of age, whose health condition allows them to participate in the Tournament, hereinafter referred to as "players" or "participants", who will form a team in accordance with the rules set out in §5 section 2 and 3.
2. The tournament will take place on May 29, 2022 at the Municipal Stadium in Białystok at Słoneczna Street. The detailed schedule of the Tournament will be established after the registration of the teams is completed and will be posted on the MUB website: www.umb.edu.pl.
3. Team registration runs from May 6, 2002 to May 20, 2022 or until all places have been filled. Qualifying for the Tournament is determined by the order of applications and delivery to the e-mail address promocja@umb.edu.pl of the proof of payment of the donation referred to in paragraph 4. Registration takes place electronically via the form available on the MUB website at the link https://www.umb.edu.pl/turniej_karetka_dla_lwowa. The captain makes the registration on behalf of the team.
4. The condition for qualifying the team to the Tournament is to make a contribution to the fundraising for helping Ukraine - purchase of an ambulance run by the Medical University of Białystok and the Association of Friends of Cardiac Surgery in the amount of at least PLN 500 to the account:

Rules of the game

§3

1. The matches will be played on the side field of the Municipal Stadium in Białystok.
2. The matches are conducted by a judge selected by the Organizer of the competition, who is responsible for the objective conduct of the competition. The powers of the referee and the exercise of the law assigned to him by the Rules of the Game begin when he enters the venue where the competition will take place.
3. Violations committed during a temporary interruption in play and when the ball is out of play are also subject to referee decisions. The substitute player is also under the referee's jurisdiction.
4. During the match, only the team captain has the right to refer to the referee in a polite and tactful manner, not with regard to his decision.

§4

1. For unsportsmanlike behavior, such as profanity or violent play, a player may be penalized with an admonition (yellow card), or a suspension (red card) and a 2-minute penalty. Time is counted from the moment the game is resumed after the interruption to give a penalty.
2. If a player receives a second warning (yellow card) in one game, he is given a red card and is suspended for 2 minutes.
3. A red card received by a player results in a forced exit from the field of play and his absence at the next match.
4. In the case of minute penalties, the team may complete the squad 2 minutes after receiving the penalty or immediately after losing the goal.
5. The goalkeeper will also serve a penalty if he receives it (it is unacceptable for a field player to serve the penalty for the goalkeeper).
6. Penalty kicks will be taken from the 7 meter line.

§5

1. The duration of the match is set at 20 minutes in a schedule of 2 x 10 minutes.
2. Teams are composed of 6 people, including a goalkeeper.
3. The maximum number of players entered in each team may not exceed 15 people.
4. Each team can make changes during the match in any number.
5. A maximum of 20 teams may be entered in the tournament.

§6

1. The matches will be held in four qualifying groups (groups A, B, C, D of 5 teams each) and will be played in a *everyone with everyone* system.
2. The matches are held simultaneously.
3. The teams that took the first place in the group will be promoted to the semi-finals.
4. The teams that win the semi-final matches will be promoted to the final.
5. Teams that did not win in the semi-final match will play for the 3rd place.
6. The order in the groups is determined by the number of points scored: for a win 3 points, for a draw 1 point, for a defeat 0 points.
7. In the event of the same number of points obtained in accordance with sec. 6, decisive in the order of the direct match result, goal balance, number of goals scored, number of goals conceded.
8. The final team will play a match against Jagiellonia players.

Final Provisions

§5

1. All Tournament Participants are required to behave in a manner that does not endanger the safety of other people, in particular to comply with health and safety and fire regulations and the provisions of these Regulations.
2. Participants and all persons present in the tournament are obliged to follow the Organizer's order.
3. It is forbidden to bring into the tournament area and the possession by participants of weapons, ammunition or other dangerous items, explosives, pyrotechnic products, fire-hazardous materials, alcoholic beverages, intoxicants, psychotropic substances, and other substances of this type.
4. The following persons are not allowed to enter the tournament area:
 - a) under the influence of alcohol or under the influence of alcohol, drugs, intoxicants, psychotropic or other substances having a similar effect,
 - b) behaving aggressively, provocatively or in any other way posing a threat to the safety of Tournament Participants or public order,
 - c) due to the state of the epidemic, patients with COVID-19 or showing symptoms of SARS-CoV-2 infection, such as: fever, cough, shortness of breath, muscle pain, sore throat and runny nose, diarrhea and abdominal pain, vomiting, deterioration of taste or smell, and those in isolation or quarantine.
5. In addition, it is prohibited to:
 - a) enter or pass through facilities, areas and devices not intended for general access,
 - b) enter business premises, pass through places not intended for the public, fenced off or otherwise protected against access by unauthorized persons.

6. In the area of the tournament, it is forbidden to conduct any commercial, profit-making, promotional, advertising or political agitation without the Organizer's permission.
7. The organizer reserves the right to remove any tournament participant who violates the provisions of the Regulations, public safety rules, rules of personal culture or disturbs other people in the reception of the tournament.
8. It is forbidden for the Participants to take any actions that may violate the rights of third parties or the organizer.
9. In the event of noticing a fire or other event posing a threat to the safety of life, health or property, Participants and people currently in the tournament area should:
 - a) Notify the security services immediately,
 - b) Avoid panic, follow the Organizer's instructions,
 - c) Leave the tournament grounds calmly, following the evacuation signs and fire instructions.
 - d) If necessary, notify the competent service: Fire Brigade, Police, Ambulance Service (emergency number 112).
10. The Tournament participant acknowledges that participation in the tournament is associated with the risk of contracting Covid-19 and releases the organizer from any liability in this respect.
11. Entering the Tournament Area means accepting the provisions of these Regulations and the Regulations of the Municipal Stadium at Słoneczna 1 in Białystok.
12. The organizer provides only ad hoc assistance in case of injuries caused during the game, but is not legally responsible for the participation of sick people and the resulting accidents and the consequences of accidents during the game of each player.
13. The organizer is not responsible for the material losses of the participants incurred during the tournament, including the items left by the participants.
14. Any disputes arising during the tournament will be settled by the Organizer.
15. The tournament will take place regardless of weather conditions.
16. The Organizer reserves the right to use all photos, films, interviews and audio recordings depicting the Tournament free of charge all over the world.
17. The condition for the admission of the Tournament Participant to participate in the Tournament is that he submits a declaration of the following:

I declare, that:

I am 18 years old and my health condition allows me to participate in the Football Tournament
I have read the rules of the football tournament and I accept its resolutions.

INFORMATION ON THE PROCESSING OF PERSONAL DATA OF PARTICIPANTS OF THE TOURNAMENT

Each tournament participant acknowledges that:

1. The administrator of personal data is the Medical University of Białystok, with its seat at Kilińskiego 1, 15-089 Białystok, represented by the Rector
2. Contact to the Data Protection Officer at the Medical University of Białystok, email address: iod@umb.edu.pl
3. My personal data will be processed in order to conduct the Tournament and for promotional purposes related to the Tournament on the basis of my consent (Article 6 (1) (a) of the GDPR)
4. The recipients of personal data will be Society of Friends of Cardiac Surgery and may be external entities providing services related to the ongoing activities of the University, providing and supporting the University's IT systems.
5. My personal data will be stored until July 31, 2022.
6. I have the right to access my data, the right to rectify it, the right to limit processing, the right to delete data, the right to transfer data, the right to withdraw my consent at any time on the terms set out in the GDPR. I can exercise my rights by contacting the Data Protection Officer at the following e-mail address: iod@umb.edu.pl
7. I have the right to lodge a complaint with the President of the Personal Data Protection Office, Stawki 2, 00-193 Warsaw, when it is justified that my personal data is processed by the administrator contrary to the GDPR.
8. Providing data in the application form is voluntary, but without providing this data, participation in the Tournament will be impossible.
9. Based on the provided personal data, no automated decisions will be made, including no profiling.
10. Participation in the tournament involves the recording and dissemination of the image and voice of the participants by: free of charge recording, photographing, filming or making any other record of their image or voice in connection with the tournament, broadcasting, disseminating or showing their image in connection with the promotion of the tournament, in particular, posting an entry on the website, in social media, in publications, in the media.
11. The Participant is not entitled to any claims against the Organizer in this respect.
12. I will provide the above information on the processing of personal data to all team members whose data I provide in the application for the Tournament.
